

Does Maine's community solar program help small-scale solar projects?

A Maine Monitor analysis finds developers have bundled projects, then sold them to some of the world's largest corporations and investment firms. AUGUSTA, Maine -- Maine's community solar program, commonly known as net energy billing, has been wildly successfulin incentivizing the development of small-scale solar power projects.

Does the Maine Energy Office track a solar project's ownership?

Although the Governor's Energy Office tallies the solar capacity of the projects, it does not track ownership. The Public Utilities Commission posts reports filed by Central Maine Power and Versant that show the projects participating in net energy billing, but the owners are redacted.

How do solar panels work in Maine?

Solar photovoltaic (PV) panels can be installed in arrays ranging from small,residential rooftop installations that power a home to many acres of solar farm that can power entire towns - thousands of homes,businesses,schools,and other buildings. In Maine,distributed generation resources are renewable generators less than 5 megawatts (MW).

Will Maine get a \$62 million solar grant?

On April 22,2024,the U.S. Environmental Protection Agency (EPA) selected Maine's proposal for a \$62 million grant award to provide financial and technical assistance enabling low-income and disadvantaged households across the state to access solar and energy storage. This program is forthcoming,but not yet available.

Do I need a decommissioning plan for a solar project in Maine?

Solar power projects occupying three or more acres are required to file a decommissioning planwith the Maine Department of Environmental Protection (DEP). The project owners must also provide financial assurance, such as a bond, sufficient to cover the cost of decommissioning the project as outlined in the plan approved by Maine DEP.

How can NCSP improve access to community solar projects?

To improve accessibility of community solar projects that serve LMI households, NCSP requires projects and programs recognized through the Sunny Awards provide at least 40% of their project's residential capacity to LMI households.
